5. Write reflective Competency Statements (CS V) which address all items and sub-items identified in the CDA functional area of program management.
6. Compile Resource Collections (RC V) which includes all items identified in the CDA functional areas of program management.
7. Identify developmentally appropriate practices in early childhood education in the CDA functional area of professionalism.
8. Write reflective Competency Statements (CS VI) which address all items and sub-items identified in the CDA functional area of professionalism.
9. Compile Resource Collections (RC VI 1-3) which includes all items identified in the CDA functional areas of professionalism.
10. Complete a family questionnaire cover sheet and compile returned family questionnaires in a professional portfolio.
11. Review and organize all required resource collection items in a professional portfolio.
12. Review and organize all required competency statement items in a professional portfolio.
13. Review and revise a professional philosophy statement as a part of the professional portfolio.
14. Review site visit procedures and requirements.
15. Review and discuss CDA credential exam questions.
